The Upper York Sewage Solutions (UYSSolutions) project is about development of a sustainable sewage servicing solution in accordance with the *Environmental Assessment Act* and all applicable government legislation. This infrastructure is to accommodate and manage projected approved growth in the Towns of Aurora and Newmarket, and the Communities of Holland Landing, Queensville, and Sharon.

Environmental Assessment Process

At these drop-in Public Information Forums, you will learn about the UYSSolutions Individual Environmental Assessment (IEA) process that York Region is required to follow. Share your ideas on what opportunities and solutions should be considered, what features in your community are important to you and how we can best involve the public in a meaningful way throughout the UYSSolutions IEA process.
